#### FIRST ORDER OF BUSINESS

#### Call to Order/Roll Call

Presentation of Engineer's 2020 Annual Report – Section 9.21 of Master Trust Indenture

Mr. Schaeffer reviewed the Annual Engineer's Report for 2020, as follows:

- Construction commenced on Phase 1A, Unit 1, consisting of a spine road, residential roadways and lots.
- The project was anticipated to be completed in late August or early September.
- Delays were caused by Florida Power & Light (FPL).
- Units 2 and 3 were in progress and should be completed in the first quarter of 2021.

"Dissemination agent": Change "3,500" to "1,000"

"Information technology": Change "3,700" to "1,890"

Corresponding "Totals" lines and any other items would be adjusted to account for the reduced amounts listed above.
